

Mission

The purpose of Montrose Redevelopment Authority and City of Houston TIRZ No. 27 is to <u>finance construction of public</u> <u>facilities and infrastructure necessary</u> to catalyze residential and commercial development and redevelopment within the Zone boundaries.

- 4. Develop and enhance open space, parks, plazas, recreational

amenities, cultural facilities, and other similar improvements.

5. Facilitate affordable housing in the Zone.

- Waugh Dr: Westheimer Rd to W Dallas St
- Commonwealth St: Haddon St to Yoakum Blvd
- Montrose Blvd: Hawthorne St to Fairview St

• Over 2.2 miles of improvements








Approximate SMA Boundary





Project Objectives

- Improve Safety & Mobility:
 - Mill and Overlay Existing Deteriorated Asphalt Pavement and Re-stripe Roadway
 - Convert to Neighborhood Safe Street Corridors
 - Intersection modifications focused on safe pedestrian and bicycle crossings and safe vehicle speeds
- Improve Pedestrian Facilities:
 - Continuous, Uninterrupted & Wider Sidewalks





Safe Neighborhood Streets

Definition:

A Neighborhood Safe Street is a corridor designed so that roadway users of <u>All Ages and Abilities</u>, no matter their mode of travel, will feel safe and comfortable traveling along that corridor.

Why these Corridors?

- Support a larger bikeway network
- Both Corridors is currently signed as bicycle routes.

 - Deteriorated/Poor Condition


Existing Sidewalks

- Poor Condition
- Inadequate (not City Compliant)
- Settled
- <u>Ramps</u>
 - Poor Condition
 - Does Not Exist at Some Locations
 - Not ADA & City Compliant



Grant:

METRO 5310 Program

Limits:

Woodhead St. to Montrose Blvd


Proposed Improvements:

- \$814 K (\$500K Federal Funds)
- Accessible sidewalks and ADA compliant corner Ramps

Current Status:

- Construction commences June 2023
- 7-month duration





W. Dallas & Mandell Streets

<u>Limits:</u>

- <u>W. Dallas St:</u> Waugh Dr. to just east of Montrose Blvd (2,200 LF)
- <u>Mandell St</u>: US 69 to Fairview (4,120 LF)


Proposed Improvements:

- > \$2.2 Million
- Mill and overlay of existing deteriorated asphalt pavement
- Intersection safety improvements
- Accessible sidewalks and ADA compliant corner ramps
- Dedicated Bikeway Facilities
- Signal modifications, Signing & Restriping
- City is doing rehab work

Current Status:

- 90% Completed
- Delayed due to City WL project along Fairview





Montrose Boulevard

Purpose:


- Create a signature corridor
- Improve drainage, mobility and quality of life.

Limits and Cost:


- 2.1 miles (US 59 to Allen Pkwy)
- > \$57 Million

Current Status:

- Phase I/II: Preliminary Engineering Completed
 - Currently incorporating a bike facility to corridor
- Phase I Currently Under Design
 - Construction early 2024
 - \$13 Million




Montrose Boulevard – Typical Section

Purpose:


- Pursue federal grants in a joint effort with neighboring TIRZs
- Improve mobility (High-comfort Bike)
- Drainage
- Quality of life

Limits and Cost:

- 1.7 miles (Shephard Dr to Spur 527)
- > \$25 Million

Current Status:

Preliminary Engineering - Completed
